2019 Congregational Council Report Marsha Schroeder, Council President

Can you feel it? The winds of change are blowing through Emanuel's like the Holy Spirit. The year of 2019 was when we took great strides, some might say giant leaps, in fulfilling goals set before us in our Vision 2020.

We helped and encouraged Pastor Marcus as he worked to fulfill the duties of his Call to Emanuel's. He established and strengthened the ties between Emanuel's and other churches in Seguin as they worked on joint ministries. Some are still works in progress as other priorities arise in other congregations. He has not given up and continues to seek ways to serve the community as a whole, while keeping his obligations to Emanuel's at the forefront.

We were able to call a young pastor to partner with him in ministry. Pastor Kelsie came on board in February and is sharing her expertise in youth and young adult ministry. She spent a good part of the summer taking our kids to camp; she has established a monthly event for young adults called "What Would Jesus Brew?" for fellowship and discussion. She is sharing her eye for beautiful design in refreshing the worship space. The altar area was nothing short of spectacular during Lent and Advent. She is still finding her way in some areas of ministry but under the excellent mentorship and supervision by Pastor Marcus she is growing all the time.

An area of ministry included in both Pastors' calls and Vision 2020 is to re-establish and strengthen the ties between Emanuel's and Texas Lutheran University. When an emergency situation arose just before the Fall Semester, Pastor Kelsie and Pastor Marcus stepped in to help part time as Interim Pastor. They are being paid by TLU for their ministry there in addition to the salary they receive from Emanuel's. I feel I need to clarify the situation. They both realize that duty to Emanuel's comes first. Their TLU office hours are limited and staggered so only one of them is there at a time. They are only a phone call away and there has not been a time that someone from Emanuel's needed a pastor and they were not responsive. TLU is in the Call process and the plan is to have a full time Campus Pastor selected and on board this summer. The pastors' involvement at TLU is bearing fruit for us as we have several students worshiping with us regularly; one has joined Emanuel's and is on Council now – Caroline Bowers.

We made progress in our renovation efforts this year. The roof area by the air conditioner has been replaced to stop the leaks. The LWR quilters have been moved to the first floor to a larger space where they are able to store their supplies all together. The beautiful new ramp to make it easier to access the Fellowship Hall is finally done. With financial support from the Ladies Aid, we were able to replace the flooring (rip out the old stained carpet) from the Mountain Street entrance and the first floor and make that area inviting again. If you have not been to the first floor within the past couple of months, be sure to check it out. THANK YOU to the Ladies Aid for making that happen. The renovation projects are being prioritized so as to not impact the budget as heavily and all at once. It looks like the next area to be addressed is the Fellowship Hall itself. God has truly blessed us with members who have the professional expertise and the time to work on these projects. It is with their assistance that we are able to accomplish as much as we have. Information will be coming soon about a capital campaign in order to fund the future projects.

The Stewardship Drive that just concluded for 2020 was very successful. This is a gentle reminder that if you have not turned in a pledge for this year, you can still do so. This helps us as leaders better plan and use our resources.

Emanuel's is continuing to grow and thrive. We celebrated the receiving of many new members this year. Many of them are young families and it is a joy to see so many children in church again! We have a nursery that is staffed for all events – even choir practice! We also welcomed several retired people and we are assimilating them into areas of ministry where their interests lie.

Looking ahead, 2020 will be a busy and exciting time for Emanuel's as we celebrate our 150th anniversary. If you are interested in helping with any of the planning or the festivities, there is room for all! Contact the Church office or sign up in the narthex on the table set up for this purpose. There will be events happening all year – the first celebration will be on February 3, 2020 to commemorate the 150th Anniversary of the founding of the congregation on January 30, 1870. In August we will celebrate the first service held in our present location, and on Reformation Sunday, we will celebrate the main event.

This is the end of my term on Council. Thank you for your support as a Congregation and especially to the Council team. Vice President Hazel Dalton, Treasurer Susan Yeatts, Secretary Debby Richardson have been a wonderful executive team to work with. Steve Anderson, Allan Bode, Aaron Jenke, Sarah Kent, Doug Parker, Ron Schneider, Levi Stallsworth, and Keith Vinyard are the rest of the dream team who, with Pastor Marcus and Pastor Kelsie, kept me on track. Join me in welcoming, supporting, and praying for the new Council for 2020 – President Susan Yeatts, Vice President Hazel Dalton, Secretary Emily Prochnow, Treasurer Keith Vinyard, Steve Anderson, Allan Bode, Caroline Bowers, Megan Jenke, Sarah Kent, Lindsay May, Linda Salt, and Ron Schneider.

Annual Congregation Report The Rev. Marcus A. Bigott, Senior Pastor Emanuel's Lutheran Church, 2019

"For I am not ashamed of the gospel; it is the power of God for salvation to everyone who has faith, to the Jew first and also to the Greek. For in it the righteousness of God is revealed through faith for faith; as it is written, 'The one who is righteous will live by faith.'" (Romans 1:16-17, NRSV)

Dr. Martin Luther, the 16th century monk-reformer and our denomination's namesake, was a driving voice when it came to holding a greater centrality of Scripture as the Church's norm. If the Church was going to make changes to its belief systems, its governing policies and practices, and its lived actions as congregations it must place Scripture alone at the center of all decisions, first. His 95 Theses, the comments on Church practices that placed him on the radar of the Catholic hierarchy, were, at their core, a return to these practices. The two verses that I have highlighted from the Apostle Paul's Letter to the Christian Church in Rome provided Luther, and many of his contemporary reformers, with the necessary scriptural footing for his (and our) beliefs. They were foundation to what Luther was teaching and preaching as the Reformation as a movement of history began to take shape and they are just as foundation, and formative, today. Our belief that salvation is a gift from God and not a result of our works, how we respond to the Gospel of Jesus Christ as the Body of Christ in this place, and how we are challenged to live differently are all seen through these words of the Apostle Paul. These verses, in a relatively few short words, sum up the mission and ministry to which we are called: 1) passionate proclamation of the Gospel of Jesus Christ that salvation is for all through faith and 2) living a life that is reflective of God's righteousness and a faithful commitment to the transformative work of the Holy Spirit. How we as a congregation have been a part of this work, over the course of 2019, will be the bulk of my report this year.

- "God's Work. Our Hands." Sunday, September 8th: From Elin Oelke, "Early Sunday morning brought a lot of "God's Work" to Seguin. Bags of trash picked up along residential streets between Emanuel's and Park West filled the pickup bed. The Christian Cupboard garden was cleaned up, shelves were stocked, and large bags of kitchen staples were re-packaged for distribution. At Emanuel's, Lutheran World Relief projects 30 quilts, 100 school kits, 48 personal care kits were completed. Two-hundred-fifty hygiene kits were assembled and delivered to San Antonio's Interfaith Welcome Initiative. Thank you notes were written to 82 first responders and military members. Projects were supported by donations and Thrivent Financials. The joyous work of members of Refuge Church of our Lord, Spirit of Joy, and Emanuel's led into joint worship and lunch. A special, memorable God's Work Our Hands Day!"
- Summer Camp: Summer camp took place the week of June 9-14th and June 30-July 5th at Lutheran Camp Chrysalis in Kerrville. Ten youth plus Pastor Kelsie and I made the trek to camp for the weeks. One of our high school students attended Ebert Ranch Camp the June 23-28th for the LYLE 1 program. These weeks away provided a time for us to bond as a group, as youth and pastors, and as a church family away from the normalcy of church life. These weeks also spurred a continued excitement for our confirmation cohort program that began in August 2018. A huge thank you must be given to each of the parents and guardians who entrusted their youth to the care of Camp and our pastoral staff for the weeks we were away, as well as each member who provided funds to make this week possible for every person who wanted to attend including tamale sales.
- Summer Day Camp & VBS: Emanuel's and Spirit of Joy teamed up again this year with Cross Trails
 ministry to host an onsite day camp program for our children and youth and those in the community.
 This week of festivities took place the week of July 17-21st and played host to 40 youth. Continuing our

traditional summer programming and running concurrently to this program was our week of half-day VBS for those in our Day School and other preschool-aged students with a total of 40 kids as well. Without the leadership of our volunteers, whether they were in classrooms, managing food and meals in the kitchen, or planning the curriculum and crafts, this crucial part of our summer programs would not have been successful. Thank you to each one of you who made it all happen. You helped spurn a renewed energy behind our children, youth, and family programs!

- 123 Confirmation Cohort: We celebrated a joint Confirmation Sunday service with Spirit of Joy on Sunday, May 26th at Nolte Island. We had four confirmands affirm their faith amidst the gathered assembly and a delicious potluck was enjoyed by all. Continuing our revitalization of our confirmation ministry in 2018, 15 youth from Emanuel's join alongside 5 youth from Spirit of Joy and 4 youth from St. John's, Marion, creating the 123 Cohort. We rotate between the Synod Office, the Women's Ministry Room, and the fellowship Hall of St. John's to hold our classes. We changed the way in which we gather by coming together later and condensing our afternoons together. WE still gather once a month but do so for our two hours instead of three. With this continued and growing partnership, our youth are studying and interacting with classmates and friends and bringing a new sense of joy to what it means to be church.
- Sunday Children & Youth Rotation: Following on the heels of 2018, we continued the rotation-style education program for our children and youth into 2019. The rotation, including Children's Church, Sandbox Stories, and Faith, Bible, and Science sought to engage our youngest through middle school learners in new ways. Participation continues to hover around the same levels we had at the beginning our programs. Continued evaluation has proven that additional ideas of engaging these learners needs to take place. I am forever grateful to all of those who continue to pray and dream about what might be next for some of these programs. 2019 ended with wonderful energy behind our Sandbox Stories and Faith, Bible, and Science and I am hoping to build on that with a new rotation-style program to be unveiled in May 2020.
- Associate Pastor: It has been an absolute joy to have welcomed Pastor Kelsie Theiss onto our staff. Her energy and excitement for the work we are collectively called to is infectious and has brought a renewal, in many ways, to our youth and family programs. She has been entrusted with the focus of 8th grade through college students and their families, as well as the pastoral commission of worship, funerals, weddings, and the sacraments. As we both continue to learn the rhythms that work for us and our ministries, I am excited to see some of our dreams and hopes come to fruition in the coming year.
- Cross Trails Ministry Board: As I have done over the past year, I continue to serve as Vice-President of the Board. I am excited to continue to be a part of the leadership of this ministry in visioning and planning, especially as we undertake a large capital campaign later this year. I grateful the board sees the gifts in me to serve in this capacity for another year. My term and required time away from the Board will take place in October of 2022.
- ELCA Church Council, Executive Committee: I was elected to serve as a National Council Member following our 2018 Synod Assembly and have begun my six-year term. In conjunction with this honor, I was also elected to serve on the Program and Services Committee and the Board Development Committee, as well as the Executive Council for the ELCA. This is a great honor for me and our church family as it will place our voice at the table for church decisions, direction, and visioning as we not only grow locally, but as we grow nationally.
- ELCA Behavioral Interviewer: For the last five years, I have facilitated interviews for the ELCA as a Behavioral Interviewer. Anytime a rostered leader desires to enter the work of redevelopment (helping revitalize a current, struggling ministry), a development (church planting or new site creation), or enter specialized, non-military ministry, they go through an interview process. At the conclusion of the interviews, I and the other interviewer offer suggestions and recommendation to Bishops and DEMs as

to how the past and present behavioral tendencies might impact the work they are called to. On average, I do 4-5 interviews a year, with each interview taking 4-6 hours. As my own plate has become quite full, I asked to be placed on an emergency only list for these interviews starting in June 2019. I will resume my role in this vital process for our church in the fall of 2020.

- TLU Adjunct Professorship: I continued my role and post as an adjunct instructor in the Spring and Fall of 2019. I was fortunate to teach, in the Spring, the Foundations of Youth Ministry class that has reinvigorated my passion for youth and youth ministry. I was a part of a growing movement in the Theology Department regarding majors and those seeking to specialize. In the fall, I was moved to the general education side to teach an Introduction to Theology class for incoming freshman. This was a great time to dive back into theological thought, Bible study, and learning that I had engaged in a while. I am thankful for the time to be able to teach on my lunch hour and for the support of the Council and Department to offer my gifts in this way.
- TLU Campus Ministry Interim: Following the departure of the full-time campus pastor, Pastor Kelsie and I stepped into a part time, 10-hour a week interim position to facilitate chapel, small group ministry, and Sunday worship for the campus. A search for a new pastor was begun in the fall of 2019 with a hopeful hire/call sometime in the spring of 2020. We are both extremely grateful for this opportunity to serve the University and its students, faculty, and staff in this way.
- Pastoral Leadership in Public Life: I was nominated by Bishop Sue Briner and began this two-year
 cohort program through Austin Presbyterian Seminary in August 2019. This program encourages and
 equips pastors to find and strengthen their public voices, as well as their pastoral witness. The
 Education Beyond the Walls program of the seminary designs and guides each cohort meeting, which
 take place every other month, Sunday evening through Tuesday morning, and are funded by the Lily
 Foundation.
- Seguin Ministerial Alliance, Community Partnerships, & Community Relations/Programs: I was blessed to be asked to help lead this year's National Day of Prayer ceremony alongside the Ministerial Alliance. This program featured prayers and addresses from civic and county leaders, seven local pastors and congregations, and SISD. Community engagement has always been a passion of mine and I was thankful to be able to stretch those wings. In conjunction with these programs, I was able to forge new partnerships with community programs, offering them office space and places to meet and work from, that will only grow our ministry footprint in the community. I know 2020 will bring new opportunities to open more doors and I pray we are all ready for what the Spirit will do in our midst.

These bullet points could go on further but as I stated last year, I am sure you are tired of reading! I hope you find this small window encouraging because it is not just the work that I am called to or the work that you are called to, it is the mission and ministry we are all called to by the Spirit. Through each of these points, you and I accompany the Spirit of God in a work far greater than we could ever accomplish on our own. We are co-journeyers in faith, proclaiming a message of hope and grace amid a chaotic work, sowing seeds that we faithfully know God will transform into beautiful fruit.

As 2019 has come to an end, I am extremely grateful that God has brought me to this congregation and to the mission and ministry we share over two years ago. This new chapter in our journey together has only just begun and with this turning of the page, the canvas is blank, the possibilities are endless, and Gospel is just waiting to be shared in new and wondrous ways. Here we go!

Annual Congregation Report The Rev. Kelsie L. Theiss, Associate Pastor Emanuel's Lutheran Church, 2019

Do not remember the former things, or consider the things of old. I am about to do a new thing; now it springs forth, do you not perceive it?

I will make a way in the wilderness and rivers in the desert.

Isaiah 43:18-19

In the past eleven months, we've gotten to know each other a little better, trust each other a little more, and have gotten to see the beginnings of the new things that God is doing in, with, and through Emanuel's Lutheran Church. As we enter our 150th year as a ministry in this place, it is always a good idea to reflect on what God has done in and through us in the previous year. In this time of transition and newness, we enter a new type of wilderness, one full of the unknown, but guided and supported by the Spirit. Thanks be to God for the transformational energy of the Spirit! The following are just a smattering of ways in which we have worked together to the glory of God this year. I am extremely excited to see the ways in which we journey together and grow together in God's ministry in this place.

- ELC Youth Group: 2019 saw new events and fun for our ELC youth. We grew in relationship around food and fellowship throughout the year. Bowling, an escape room, age-grouped retreats at camp, and an evening out to a corn maze were all amazing opportunities for the youth and I to get acquainted and learn to trust one another. Add that to a few weeks at camp, a high school service trip to the border, and VBS here with Spirit of Joy, and it was QUITE the full summer! I look forward to continued program growth with the continuation of a high school service trip this summer to New Orleans in partnership with two other synod congregations.
- TLU Interim for Campus Ministry: After the departure of TLU's full-time pastor a couple weeks before the term started, I inquired as to what ways PM and I, both alumni of TLU, could help support the ministry in the interim. After conversations and planning with the Dean of Student Life and Learning, PM and I were asked if we would help to support Campus Ministry while they discerned what was needed in a campus pastor and began a call process. With only 10 hours a week, PM and I are renewing relationships and passions for worship and ministry with the students and faculty we've encountered. You might have even seen some of them on Sunday mornings! I'm so grateful and delighted to serve the University and its students, faculty, and staff in this way and get Emanuel's name out there in the process!

The Jubilation Singers regularly sings on 2nd and 3rd Sundays, Festival Days, and on other Holy days.

It pleases me very much to be able to celebrate the existence of the Joy Choir, which is composed of members of the Mosaic Community among. These spirited and dedicated folks meet on Tuesday morning at the church, and we sing favorite songs and have a bible study together. Day School Report to the Annual Congregation Meeting

February 2, 2020

"When schools flourish, all flourishes" - Martin Luther



The year 2019 was one of new beginnings and building upon the successes of programs begun earlier in our history. The Day School has operated for two years under full enrollment with a waiting list in each classroom. Tuition was minimally increased in 2019 after a significant increase in 2018; tuition will be increased again for the upcoming 2020-2021 school year. Small but consistent increases in tuition together with a full enrollment have allowed us to add a TEA-certified teacher in Pre-K4 in 2019, as well as keep the Pre-K3 and Literacy Skills Program teachers, both TEA-certified. Our Toddler program has had consistent growth and enrichment for five years under the leadership of a Lead Teacher with seventeen years of experience working with infants and toddlers in early learning centers.

As a result of consistently full enrollment, the Day School has been able to move from a starting wage for staff of \$7.25/hour in 2014 to a competitive minimum of \$9.15/hour in attempts to attract and keep qualified personnel to teach, nurture and care for our youngsters. The Day School was able to move further toward its goal of self-sufficiency without the aid of general operating funds from the church. The Congregation Council allotted \$10,000 in benevolence for Day School use in 2019; *however, the Day School never drew upon those funds*. Council did not assign benevolence funds to the Day School in 2020.

The Day School has had significant maintenance issues with the HVAC system, bathroom plumbing and exterior paint. We are blessed with a wonderful group of Property Stewards who have coordinated the maintenance efforts here at school and kept costs at a minimum for repairs and replacement of equipment.

Lights and filters are now changed by the Property Stewards along with minor repairs, emergency fire alarm

batteries and a host of other maintenance issues. New floor tile for the children's bathrooms was donated when the toilets and flooring had to be replaced due to continued leaks. Complete power washing of the building exterior and playground equipment, along with clearing the gutters are scheduled for early spring in time for March registration and visits from prospective families. We are all thankful for the time, commitment and generosity of this supportive group of volunteers.

A software program has been instituted to offer quality online training for all staff members for an annual fee; this has reduced costs and increased convenience and efficiency in staff training. The Day School Director and Director of Church Finance are cross-trained on the Brightwheel app providing communication, financial, and attendance support as well as the continuing education software. A teacher assistant/office assistant was added in December to teach the children in case of teacher absence, teach the Pre-K3 classroom each afternoon, close the center, and provide technical and classroom support for teachers and the Director. This assistant will also be able to answer phones and conduct school tours in the absence of the Director.

A renewed Day School Task Force dove into the renovation and expansion plans of the Day School facility in February 2019 to add infant care, after-school care, a kitchen facility, additional classrooms and large multipurpose room. Members of our Task Force met frequently with City of Seguin officials for information on permitting, surveying, drainage and landscaping requirements. An architect was hired for the initial rendering of schematics, pictorial facility sketches and proposed budget. Substantial progress was made on planning a flexible-space renovation and expansion of the current facility and programming. Plans have been submitted to the Council. Seguin ISD's creation of an all-day Pre-K4 program for 2020-2021 has presented a challenge for the Day School, but also a great opportunity to seize upon creative new programming with an updated, attractive space to better meet the needs of our community and partner with Seguin ISD in providing early childhood education and care.

The playground pea gravel surface has for years presented substantial challenges for staff, children and parents. Pea gravel is easily stuffed in pockets, mouths, ears and noses, not to mention easily thrown at friends on the playground and, in a few instances, causing minor surgery or injury. Parents have complained that their washing machines and dryers have a layer of rocks in them at the conclusion of each laundry period! During the summer of 2019 it was necessary to order and spread over \$1000 in replacement pea gravel to meet the new state standard of 9" depth in the fall zones on the playground. Therefore, we held an "Abolish the Rocks" fundraiser in December to replace the pea gravel with a more user-friendly surface such as a padded synthetic surface, from which there are many types to choose in a wide range of materials and costs. Due to the outstanding motivation of the parents to resurface the playground, the Day School was able to earn \$3,200.00 toward this goal in December 2019 with its tamales sales. This Day School Money Market "Building Fund" currently holds approximately \$9,300.00.

We are excited that our Day School ministry has been blessed to be able to reach out to our Seguin community and beyond. Our increasing diversity in families served, as well as education and child development offerings, meet and exceed the mission goals of Emanuel's Lutheran Church's largest and most visible community outreach ministry.

Thank you for your support and encouragement for the ministry of Emanuel's Lutheran Day School and its dedicated staff. It has been my passion and privilege to serve the Day School, community and Emanuel's Lutheran Church since July of 2014.

There were other donations made to Guadalupe Valley Christian Counseling Center, Red Barn Texas Agriculture and Education Center, Habitat for Humanity, Christian Cupboard, Earth Angles Relay for Life Team, Adam Fischer's family for their work in Kosovo.

Property Stewards Report to Congregation 2019

Our Property Stewards meet in the Women's Ministry Room every Tuesday at 8:30 to work on facility Maintenance and Church Projects.

Our weekly tasks include: replacement of light bulbs; setting up and tearing down tables in the Fellowship Hall; checking Fire extinguishers and Emergency Exit lighting; Facility repairs; work orders from Staff; operational support of the Boiler and Chiller systems; and Ground Maintenance. We also do work at the Day School and the Luther House.

2019 Projects include:

- Installing a cleanout near the Bell Tower and grading lawn so as to move rainwater away from the Bell tower and into the catch basin. There is still a small amount of rainwater that gets through. We will work on this,
- Cleaning of all drains feeding the large french drains leading to Gonzalez and Mountain streets. This allowed us to identify water issues in the Fellowship Hall and resolve them at no cost to ELC.
- Demoing non-functioning drains at the old elevator shaft and replacing them with new drains. The drains now pull rainwater away from key window wells, keeping water out of the Fellowship Hall.
- Cleaning gutters along Travis and Gonzalez street sides.
- Coordinating tree trimming by Mike Kriewaldt at large saving to ELC.
- Certification for Allan Bode and Garry Miller to lead asbestos abatement projects at large saving to ELC.
- Removal of carpet in the 1st Floor Hallway and in the Mountain St entrance.
- Asbestos abatement for the 1st Floor hallway
- Coordinating Vinyl Composite Tile (VCT) contracts and installation as well as floor maintenance.
- Documenting all HVAC and Electrical Panel assets
- Cleaning or replacing all HVAC filters. This had not been addressed in quite a while.
- Replacement of Boiler water temperature sensor
- Coordinating an HVAC service agreement
- Getting estimates for window replacement
